TOWN GOVERNMENT

Town Supervisor Ed Lentz and Town Clerk Charlene Wells are retiring from town government. Brian Ryther will become Supervisor, Jill Woodbeck will become Town Clerk & Tax Collector and Amy Dill and Bob Schenfeld will join the Town Board.

People sometimes ask, "What does our town government do?" Here's a summary:

- Budgeting and managing taxpayer funds
- Highway improvements and maintenance
- Fire protection and EMS
- Land use regulation
- Property assessments
- Justice Court
- Dog Control
- Maintaining Cemeteries
- Streetlights (Garrattsville only)
- Maintaining the town hall and community room and the community park/playground
- Ensuring the town complies with federal, state and county laws and regulations
- Town Clerk/Tax Collector functions (too numerous to recite!)

TOWN FINANCES

Town finances are in good shape. Despite recent high inflation, the 2026 town tax levy increased by only 3%, which is below our NYS Tax Cap (with credits from prior years) and less than increases in neighboring towns. The increase is \$24,252, which averages out to about \$23 per parcel. Our fund balance, which is earmarked for future needs, foreseeable and unforeseeable, is on plan.

TOWN HIGHWAYS

Our Highway Garage became operational in December 2023. With two full years under our belts, we can safely say that the project was a success. The old highway garage has been re-purposed as a salt/sand shed. In 2025, we purchased a MowerMax, which is a tractor specially designed for roadside maintenance and which improves effectiveness, efficiency and safety for our Highway Workers. We will soon take possession of a new dump/plow truck. Meanwhile, our 2018 truck, which was totaled in a crash last spring, is being rebuilt

by our Highway Workers. When it becomes operational, we can stop relying on our 2009 truck, which is our most expensive truck to maintain.

The Highway Department does a great job maintaining our town roads. In 2025, the town resurfaced parts of Jacobson and Buck Schoolhouse Roads, and the Turnbull Road bridge, and prepped Myers Mills Road for surfacing in 2026. This is all in addition to "routine" maintenance, like ditching, repairing culverts, mowing, tree trimming, honing, etc.

Please remember that it is unsafe, and unlawful, to place snow, debris or anything else on town highways or in roadside drainage ditches. If you have concerns or questions about our roads, please discuss them with Highway Superintendent Don Smith (607 965 8287).

CLIMATE CHANGE

We installed a PV system on the town hall roof. Three months in, our NYSEG bills have gone down to almost nothing. For more information, contact Councilperson Nancy Martin-Mathewson (607 263 5784).

DOG CONTROL

Remember that dogs must be vaccinated for rabies and licensed by the town. If you have an unlicensed dog, please contact Town Clerk Jill Woodbeck. If you encounter a loose dog that appears to be lost or distressed, call Dog Control Officer Keegan Holt (607 287 9639).

LAND USE AND BUILDING CODES

A local law codifying the town's 75' setback requirement was adopted. A copy of the law can be found on the town website. If you are planning to install or modify a driveway, change the use of your land, subdivide, or make other changes, please consult the Land Use Guide, which is on the town website. You can also check with Clerk Jill Woodbeck.
